1 Bee Equipment Packaging Options

1.1 Using a Steritech Bee Carton

- 1.1.1 Steritech will supply a carton (internal dimensions L56cm x W43cm x H42.5cm) and plastic inner liner.
- 1.1.2 The Bee carton can be reused up to five (5) times, if kept in good condition.



1.2 Wrap and strap your Bee boxes

- 1.2.1 Single or double-stacks no greater than 25kg each.
- 1.2.2 Use strong wrapping or bags
- 1.2.3 Strap or tape boxes after wrapping.



2 Conditions for Supply of Service

- 2.1 Steritech services will be delivered as per Steritech's Agreement for Irradiation Processing.
- 2.2 A clean-up fee of \$275.00 ex GST will be charged for processing downtime as a result of leakage of honey from customer goods.
- 2.3 A goods storage fee of \$51.00 ex GST per pallet per week begins on the 15th day after notification of completion.
- 2.4 Polypropylene components have been shown to deteriorate when exposed to doses 28kGy and above.
 - 2.4.1 Steritech Wetherill Park cannot guarantee the dose will stay under 28kGy, and cannot be held liable for any damage caused by the treatment.
 - 2.4.2 It is advisable to remove polypropylene items or contact Steritech to discuss Supply of Service.
